



## What You May Not Know about the Covid-19 Virus

If you are still living in fear about catching the Covid-19 virus, you are not alone. Millions of people remain frightened about it – and it is unfortunate, because, in so many ways, there has never been any likelihood that most people would ever catch it. It's definitely true that there is a virus, and that many people have gotten sick and suffered, and some of those have died. **But there has never truly been a pandemic as we've been led to believe.**

This ebook will explain why. It is basically a compilation of dozens of articles and videos with information from **highly-credible front-line doctors, scientists and independent investigative journalists** that has not been reported through the mainstream news, but has streamed through the internet for many, many months during 2020.

You may initially think what you read here is all “conspiracy theory”, because it offers information so radically different from what the mainstream media has presented. However, if you can keep an open mind, you will undoubtedly see the truth behind all the misinformation about the virus and the lockdown situation that we have been told from “official” sources.

It can be difficult at first to take in information that is so different from what you have believed to be true – especially when you’ve initially been given information about something that creates a great deal of fear in you. **The fear tends to lock in whatever information you’re taking in, no matter how false it may be** – and make it hard to receive new information that is different, even if it’s obviously logical and true. But do your best to simply keep reading and clicking on the multiple links to sources that are offered, in order to see a greater truth than you may be aware of.

### **False Numbers**

First, let’s start with the information given through the media about the numbers of people who have either been diagnosed with Covid-19 or have died from it, and see what has *not* been reported. And let’s start first with the number of deaths reported.

Although the mainstream media has continued throughout the months to report escalating numbers of deaths due to the virus, in September 2020, it was reported on the Center for Disease Control website itself (albeit very quietly), that **only six percent of the Covid-19 deaths it had previously reported were deaths that could actually be attributed solely to the virus.**

We had been told that the virus had killed over 180,000 Americans since March. This means that 94% of the 180,000 fatalities attributed to the disease had **other major co-existing factors involved in the deaths.** As it turns out, according to the newly released CDC data, only 10,800 of those 180,000 can truly be attributed solely to the virus.

In fact, you can look at the map on the CDC site itself to **see clearly that the “pandemic” – if it ever existed – is over.**

Even back in May 2020, the CDC had already admitted its estimates to be faulty. It came out with a report that should have been earth-shattering to the official narrative, yet it went into the thick pile of vital data and information about the virus that somehow never got out to the public.

In the report, the CDC attempted to offer a real estimate of the overall death rate for Covid-19; and under its most likely scenario, the number was 0.26%. In sum, the **CDC formally showed that the number of deaths from Covid-19 were no worse than that from the annual flu** that shows up every fall.

## Faulty Diagnoses

Now let's look at the false numbers of *infected individuals* that have also been reported. Doctors and independent journalists had been questioning these for a while, but finally in September 2020, even the NY Times admitted that the numbers had been way off.

In addition, it also reported that the tests given to people for the virus were faulty, in that they were "**diagnosing huge numbers of people who may be carrying relatively insignificant amounts of the virus**" and "**are not likely to be contagious.**" Because of faulty procedures used at *every single testing site in the country*, "**up to 90 percent of people testing positive carried barely any virus at all.**"

How did this false counting of deaths and infected individuals even happen? How could the numbers have been so off?

**Dr. Ngozi Ezike**, director of Illinois Department of Public Health, explained: "The case definition is very simplistic."

"It means, at the time of death, it was a Covid positive diagnosis. That means, that if you were in hospice and had already been given a few weeks to live, and then you also were found to have Covid, that would be counted as a Covid death. **It means, technically even if you died of a clear**

**alternative cause, but you had Covid at the same time, it's still listed as a Covid death."**

Using this same protocol, medical examiners in Michigan also reported classifying any deaths as Coronavirus deaths when the postmortem test was positive. **Even people who died in suicides and automobile accidents met that definition.**

Thankfully, there have been medical staff who've been appalled by this practice. One of these was a **nurse who came out with a video** on Facebook gaining four million views, in which she tells how **her father had died of Alzheimer's disease**. When she received the death certificate, she was surprised to see that it reported that **Covid-19 had caused the death**. She wanted to have this wrong information corrected and contacted the family doctor. His answer was shocking to her:

**"Orders from above by the National Health Service. Anyone who dies during this period should be registered as Covid-19."**

But it gets even worse. There was another **highly experienced nurse from Florida**, who decided to go to New York's Elmhurst Hospital to help out with the crisis there. What she saw in this hospital filled her with so much horror, she decided to take a **hidden camera with her to film what was going on**. Here's what she reported:

**"Patients who repeatedly tested *negative* for Covid-19 were still registered as 'confirmed Covid-19' and they were treated as such. And they were put on a respirator in a covid ward... *which caused them to die.*"**

These practices were not only happening in the US. In Hamburg, Germany, a prominent forensic medicine professor, **Klaus Püschel**, with vast experience in autopsying individuals who had died with the Covid-19 virus, stunned an audience

by claiming that the hysteria over the coronavirus was “completely exaggerated,” as **all fatalities he examined had serious previous illnesses which would have soon resulted in death with or without the virus.**

There were a number of other doctors in the US toward the middle of this year who also came out these kinds of statements, but many of their youtubes or blog posts have since been censored and banned.

Then, by the end of the summer, the numbers of infected individuals began to fall, even according to US mainstream media reports. So a new scare suddenly appeared – a **second wave of the pandemic was going to begin** when the **students began re-entering universities and infecting each other.** Astronomical numbers of probable – and supposedly real – cases began appearing in the news.

And yet, statistics based on public data from the Indiana State Department of Health, StatsIndiana, and the Insurance Information Institute came out at the end of September that showed that students were **more likely to be killed by a dog or lightning than they were to die of Covid-19.**

Out of the 48,299 Covid-19 cases “officially” counted at 37 US universities, **only two hospitalizations and zero deaths had actually happened.** There is a chart you can see, listing all 37 universities and the number of claimed cases and the true number of cases that were real.

## **Faulty Tests**

Then there’s a further piece of information that’s important to understand about the situation: It’s that, according to many medical experts, the **Covid-19 test itself** (known as a pcr test) **is actually useless.**

It evidently does not test for the virus itself, but rather *the reaction to the virus*. **It merely tests for RNA sequences that could be caused many other things, not simply Covid-19.**

This information has been validated by **Dr. Reiner Fuellmich**, a consumer protection trial lawyer in Germany and California. He claims that **there is no coronavirus pandemic – only a pcr test pandemic.**

As a member of the German “Corona Investigative Committee” he is in touch with many doctors worldwide attesting to the fact that the pcr test is useless. In an excellent video, entitled “**Crimes against Humanity**”, he also states that the **lockdown mandates came down when the virus rates were already retreating and when herd immunity was already occurring**. Indeed, it was obvious that the tests for Covid-19 were faulty, even back in May 2020. Suspicious of them, Tanzania’s President, **John Magufuli**, dismissed imported coronavirus testing kits as useless, saying he had sent in **samples of DNA taken from a goat and a pawpaw fruit, and these tests had returned positive results for Covid-19.**

So, why would most doctors and hospitals just go along with this insane practice of declaring deaths as Covid-10 deaths, when they were obviously caused by other factors? And why would they continue to count people who had tested positive by the faulty tests as contagious?

There’s a very good reason. Dr. Scott Jensen, who is also a Senator of the state of Minnesota, stated in an interview: **“Hospitals receive as much as \$13,900 for every patient they register as Covid-19. And for every death resulting from Covid-19, that amount is tripled: \$30,900!”** He added that testing is not even necessary. Other conscientious doctors in the US were also giving this information.

## **There is No Actual Pandemic**

As is clear at this point, there has never actually been a pandemic of Covid-19 – especially not in the US. Again, it's true that the virus does exist and people do get sick from it. Indeed, at the beginning, **back in March, there seemed to be a much more virulent strain of the virus that was prevalent** in certain areas. But when looking at the true figures the CDC has finally come out with, it's clear that **an actual pandemic has never actually existed.**

It's hard to believe, because we've been so bombarded by reports of all the people who have tested positive and who are dying in hospitals. And yet, it became clear at some point to many that maybe little of what we were hearing was actually accurate. **And maybe all the precautionary mandates about lockdown and masks have never been necessary.**

Think about it: In former years when a contagious disease appeared in a community, **it was always those who had the disease who were quarantined – not the entire, mostly healthy population.** That is what has been so strange and suspicious about the whole lockdown situation.

It may be argued that outside the US, in China and certain European countries, there was indeed a pandemic. As mentioned, some have affirmed that there have been different strains of the virus – some strains more virulent than others. And this could be true. But it is difficult to know for sure, because there are **many doctors worldwide who would agree that even what has occurred in Europe and China has not actually been caused (or primarily caused) by a Covid-19 pandemic.**

In the earlier part of the year, certain journalists and researchers were claiming, with scientific validation, that the **highest numbers of cases arose in areas in which 5G had just been installed** – explaining that 5G has been proven to lower people's immune systems, making them very vulnerable to disease. But it's difficult to know for sure, since, mysteriously, all the videos and posts written describing this fact have also since disappeared from the internet.

## Protests

However, it's clear that people in Germany, at least, have smelled a rat almost from the beginning about what they were being told regarding the supposed pandemic. In late August and early September 2020, there were **over a million people**, aware of the lies, who gathered in Berlin over several weekends, **protesting the unneeded lockdown mandates**.

Mainstream news reported that there were maybe tens of thousands of people, really downplaying what was going on. But independent reporters who were there swore there were over a million people gathered for these protests.

The last week of August 2020 also saw **gatherings of tens of thousands of individuals in London and in Dublin, protesting** stay-at-home orders, business closures, mask and vaccine mandates, as well as Bill Gates' grip on public health matters.

More recently, in **Belgium, another excellent open letter**, signed by 435 doctors, 1,439 medically trained health professionals, and 9,901 citizens, was sent to all Belgian authorities and media. Outlining every point of the truth about the so-



called pandemic, the information is **applicable to all countries that have imposed a lockdown, rather than permitting medical professionals to bear the primary job of disease mitigation.**

And finally, there was a group of **600 medical doctors in Spain**, calling themselves "Doctors for Truth", who stated that the pandemic is a "**global crime**". During a press conference, they stated:

## **Doctors Censored**

Still, the majority of Americans are still quite asleep to what is taking place, even though early on, a great many doctors, immunologists and epidemiologists did begin speaking out about all the misinformation being given to the public. One of the first was **Dr. Dan Erickson** in California. **His initial youtube**, in which he outlined clearly – with much sincerity and a great deal of data he'd gathered – how

unnecessary all the restrictions were, **received five million views**. Soon after, it was **censored by youtube**. He was one of the first to be seen as a threat to the official narrative.

However, subsequently, a number of other youtubes with clips of him speaking for just a short time were posted. In them, he explains why **all the precautions being demanded of both doctors and the population are not only unnecessary, but also highly detrimental to people's health**.

Afterwards, there were a number of other doctors who came forward and offered very similar information – and their youtubes were also censored. **Dr. Zach Bush** was especially eloquent about the subject. **Dr. Sherri Tenpenny** was another.

Finally, on July 27, 2020, a group of frontline doctors from across the US held a **"White Coat Summit"** in Washington D.C., intending to **dispel the misinformation and myths surrounding the coronavirus**. All were highly concerned with the disinformation campaign being played out in the American media.

One doctor stated, "If Americans continue to let so-called experts and media personalities make their decisions, the great American experiment of a Constitutional Republic with Representative Democracy, will cease."

Another expressed: "This story is really quite simple. If you look behind the curtains, you'll see this medical story with Covid-19 is...A SCAM – IT'S FAKE. **So we need to ask who gets the benefit out of this and who has got the power to CREATE THIS FAKE.**"

Not surprisingly, shortly after their presentation, and after 17 million views, the videos from the doctors were taken down by Facebook and YouTube.

All of this continued, while the **World Health Organization itself**, back in June 2020 at a press conference, admitted one of the things that many of the censored scientists kept saying: that the **virus does not spread as easily as was assumed**. ### **Covid-19 Mandates are Physically Harmful**

What is becoming all the more important to look at is the actual **harm to people's physical health** the fear-inducing information and mandates have caused. This

doesn't include the irreparable harm it has done to the livelihoods and loss of income of millions of people, which is a whole other story -- simply about the harm being done to their health.

First, let's look at the mandated use of **masks**. Aside from the fact that many doctors have said that the use of masks is not only unnecessary – and that cloth ones would be useless if Covid-19 were truly that dangerous – **wearing masks is actually harmful** for people's health.

In Makia Freeman's post, "**Unmasking the Truth: Studies show Dehumanizing Masks Weaken You and Don't Protect You**", she states:

"It is a commonsense scientific fact that wearing a mask blocks your airways and therefore leads to both **hypercapnia** (an increase in and accumulation of carbon dioxide in the body from breathing in exhaled air) and **hypoxia** (a lack of oxygen in the tissues). Symptoms of hypercapnia include dizziness, drowsiness, excessive fatigue, headaches, feeling disoriented, flushing of the skin and shortness of breath. Symptoms of hypoxia include anxiety, restlessness, confusion, changes in the color of skin, cough, rapid breathing, shortness of breath and sweating.

"Not surprisingly, both conditions are similar, since they are both characterized by a lack of oxygen. In addition, hypoxia has been shown to lead to **impaired immunity in general**, and to be a forerunner to serious diseases such as atherosclerosis, stroke and heart attack. It is also the **necessary precondition for the development of cancer...**"

This, of course makes sense: breathing in our own CO<sub>2</sub> over and over again can't be healthy for us. And think about all the people in grocery stores – and other stores and restaurants that are now opening up – who are **forced to wear masks all day long** – what it must be doing to their health.

And yet, it's not just about the people who have to wear masks, in order to keep their jobs. What about all the people who are so frightened that they actually wear **masks when alone in their own homes and in their cars**? And also when they are **jogging and biking** – or when **hiking** out in the woods, with next to no one around?

It begs the question: **How have human beings become so fearful as to not even be reasonably logical about this?** Even if the virus were as serious as we've been led to believe – it just doesn't make sense wear a mask in these solitary situations.

But, back to these doctors who began expressing the harm that the false information and the mandates were causing: aside from the issue of how masks were weakening everyone's immune system, they were also becoming alarmed about the **other harms** they were witnessing with their patients due to the lockdown situation.

In May 2020, **hundreds of doctors wrote a letter** to President Trump. asking him to end the coronavirus shutdown, saying it was a "**mass casualty incident**" **spurring deaths due to other factors**, such as **substance abuse and suicides**.

The letter, shared online, estimated that about 150,000 Americans each month that the shutdown remains in place would have had new cancer detected, millions more were missing dental exams that could discover problems linked to heart disease, while others were experiencing **domestic violence and child abuse**.

"**Suicide hotline phone calls have increased 600%**," the letter added.

In addition, it's important to remember that, due to the mandates, people who have contracted the disease have been **dying alone, in total isolation away from their loved ones**.

One way to see how utterly **unnecessary all the lockdown measures** for Covid-19 have been is to **look at Sweden**; and how, as one of the few countries in the world that never went into lockdown, it has fared through all of it. ### **How Treatment for the Virus has been Blocked**

All this would be alarming enough, if well-known treatments for the virus that have been successful in other parts of the world had not been banned in the US. In particular, the drug, **Hydroxychloroquine (HCQ), when combined with zinc and azithromycin**, became the center of a great debate, when Dr. Fauci claimed this drug was not safe and would not work to cure Covid-19.

In response to this claim, a **nation-wide team of doctors** in August 2020 wrote an **open letter to Dr. Fauci**, elaborating on the success of this remedy, asking why HCQ had been made unavailable to both doctors and patients all throughout the US.

“As experience accrued in treating COVID-19 infections, **physicians worldwide discovered that high-risk patients can be treated successfully as an outpatient, within the first 5 to 7 days of the onset of symptoms, with a “cocktail” consisting of hydroxychloroquine, zinc, and azithromycin (or doxycycline)**. Multiple scholarly contributions to the literature detail the efficacy of the hydroxychloroquine-based combination treatment.

“**Dr. Harvey Risch**, the renowned Yale epidemiologist, published an article in May 2020 in the *American Journal of Epidemiology* titled ‘Early Outpatient Treatment of Symptomatic, High-Risk COVID-19 Patients that Should be Ramped-Up Immediately as Key to Pandemic Crisis’. He further published an article in *Newsweek* in July 2020 for the general public expressing the same conclusions and opinions. Dr. Risch is an expert at evaluating research data and study designs, publishing over 300 articles. Dr Risch’s assessment is that there is **unequivocal evidence for the early and safe use of the ‘HCQ cocktail’...**

“Yet, you continue to reject the use of hydroxychloroquine...**repeatedly emphasizing the lack of evidence supporting its use.** Hydroxychloroquine, despite 65 years of use for malaria, and over 40 years for lupus and rheumatoid arthritis, with a well-established safety profile, has been deemed by you and the FDA as unsafe for use in the treatment of symptomatic COVID-19 infections. **Your opinions have influenced the thinking of physicians and their patients, medical boards, state and federal agencies, pharmacists, hospitals, and just about everyone involved in medical decision making.**”

So far, no direct positive results have come about from this open letter or from the interviews Dr. Risch has given. All this is especially curious, as it seems that **Dr. Fauci, himself, actually approved HCQ for the treatment of a Corona virus back in 2005.**

Yet, after this letter was published online, a number of **youtubes created by doctors** about the efficacy of HCQ were subsequently **censored.**

However, in August 2020, the **Association of American Physicians and Surgeons did sue the Food & Drug Administration** in a federal court for its interference with the availability of HCQ, in *AAPS v. FDA*, No. 1:20-cv-00493-RJJ-SJB (W.D. Mich.).

"As confirmed by another recent study of thousands of patients at the Henry Ford Health System in Michigan, HCQ is both very safe and highly effective in treating COVID-19, reducing mortality by 50%," AAPS informed the court in its filing.

**"Countries with underdeveloped health care systems are using HCQ early and attaining far lower mortality than in the United States, where [HHS and the FDA] impede access to HCQ."**

You may ask why, with all the people who have been infected with the virus, and the success doctors in other countries have had with HCQ, it has been made unavailable in the US. Wouldn't it be obvious that this medication could cut down the numbers of American people suffering and dying?

Journalist **Lynn McTaggart** has at least one answer to this question, which she outlines in her article, "Why Covid Treatments are Being Suppressed: Just Do the Math".

Speaking about **yet another group of doctors from major academic medical centers**, dubbing themselves the "**Front Line COVID-19 Critical Care Alliance**", she outlines how this group called an emergency meeting to discuss why the vast majority of critically ill Covid patients given the standard treatment recommended by national and international health care organizations were dying. Their main question was as to why so many patients were dying of acute respiratory failure.

Led by **Dr. Paul Marik**, this group met extensively, studying all the clinical and pathological data about the virus, and began discussions with a number of frontline intensive care unit experts working in some of the early outbreak areas, like China, Italy and New York.

**In their research, the Alliance discovered another very promising treatment for Covid-19.** They found that, when given intravenously in these emergency situations, **steroids like prednisolone and vitamin C** work together synergistically to improve survival in patients with acute respiratory distress syndrome.

Although the Alliance created a website and published (in many languages) the "MATH+" protocol they'd discovered back in March, as of August 2020, only two health centers in the US had systematically employed it to treat hospitalized Covid patients.



**“If you want to figure out why, just pull out your calculator.** The UK has just signed a deal for six experimental vaccines with Belgian pharmaceutical company Janssen and the US biotech company Novavax, for a total stockpile to 340 million doses – enough to vaccinate every British man, woman, and child five times.

“In America, the US government has spent about \$10 billion over a deal with Moderna, Inc. to manufacture and deliver 100 million doses of the company’s COVID-19 vaccine candidate...
